## Project Description

According to the Bank's website, the project consists of The Resilience and Livelihoods Guarantee (RLG) in the form of an unfunded risk-sharing instrument covering up to 50 per cent of the credit risk in newly originated sub-loans with the total value of EUR 50 million equivalent to be originated by Credit Agricole Ukraine (CAU) subject to total 50 per cent of portfolio cap.

The facility will be used to support lending to Ukrainian private companies operating in the primary and secondary agriculture and other critical industries (such as pharma, food processing, retail, logistics), with the ultimate goal of preserving livelihoods in the country.
