## Project Description

According to the Bank's website, the project consists of an EUR 25 million equivalent in USD loan with 6-year tenor in favour of Mav Elektrik Uretim Sanayi ve Ticaret A.S., a corporation incorporated in Türkiye.

The proceeds of the Loan will be used to replace EUR 10 million short-term bridge loans, and EUR 15 million shareholder loans injected to fund construction and equipments costs of the 30MWe Arikcayiri Biomass Power Plant, fuelled by poultry litter. The Loan will provide long term funding matching with long-term assets of the company.

The biomass plant is powered via a combustion system with travelling grate and three-pass boiler that uses poultry litter (a mix of manure, bedding material, residual feed and feathers) as the fuel source and conventional steam turbines.
