#### **Project Description**

According to the Bank's website, the project consists of the Food Security Guarantee (FSG, the Facility) in the form of an unfunded risk-sharing instrument covering up to 50 per cent of the credit risk in newly originated sub-loans with the total value of EUR40 million equivalent to be originated by Pro CroCredit Bank Ukraine (PCBU) subject to total 50 portfolio portfolio cap.

The facility will be used to support lending to Ukrainian private companies operating in the primary and secondary agriculture and other critical industries (such as pharmaceuticals, food retail, transportation and logistics), with the ultimate goal of preserving livelihoods in the country.
