Project Description

According to the EBRD, the investment will address the priority needs of Tbilisi City identified under the Green City Action Plan. The Project will finance the enhancement of the final capping layers and the installation of a landfill gas collection and treatment system at the Tbilisi Didi Lilo landfill.

The Project aims to contribute to an improved level of solid waste services and overall improved environment in Tbilisi. The Project will also bring landfill operations in line with the relevant EU standards.
