### Project Description

According to the Bank's website, the project consists of a senior unsecured loan of up to USD 109 million to Turkiye Is Bankasi A.S. ("Isbank") under Window 1 of the Turkiye-Disaster Response Framework ("DRF" or "Framework"), a framework for Turkish banks to support livelihoods, jobs and human capital in the South-Eastern provinces of Turkiye, affected by the February 6, 2023 earthquakes. The EBRD proceeds will be channeled through Isbank to support eligible private businesses and individuals directly impacted by the disaster, with an aim to address the most immediate funding needs of the local population in the affected cities.
