## Project Description

According to the Bank's website, Resilience and Livelihoods Guarantee (RLG) in the form of an unfunded portfolio risk-sharing instrument in the amount of up to EUR12.5 million. The guarantee covers up to 50% of the credit risk in newly originated sub-loans with the total value of EUR 50 million equivalent (the "Covered Portfolio").

The Project will support lending to Ukrainian private companies operating in the primary and secondary agriculture and other critical industries (inter alia food processing, retail, logistics), with the ultimate goal of preserving livelihoods in Ukraine.
