## Project Description

According to the Bank's website, the project consists of a loan of up to EUR 14.5 million to Compania de Apa Olt ("CAO"), the regional water operator in Olt County and neighbouring localities in Romania.

The proceeds of the loan will be used to co-finance, alongside EU Cohesion Funds, an extension and modernisation of the company's water and wastewater infrastructure and services. The EU investment grants are being made available under the EU Large Infrastructure Operational Programme approved in 2019.

The project will enable Compania de Apa Olt ("CAO") to (i) increase compliance with Directive no. 98/83/EC on drinking water quality while increasing its service coverage in communities with more than 50 inhabitants; (ii) increase compliance with Directive no. 91/271/EEC on wastewater collection and treatment by providing wastewater collection and compliant treatment of wastewater in agglomerations with over 2,000 p.e.
