# **Project Description**

As stated on the project disclosure page, the EBRD financing will support the establishment of a Customs and Logistics Center (CLC) in the Syunik region by financing the construction of customs terminal buildings and the acquisition of relevant equipment. The investment is expected to qualify for the Green building certification, resulting in Syunik CLC, along with similar centre in Yerevan, being one of the first government buildings to achieve such certification.

The Syunik Centre is expected to increase efficiency and transparency of customs operations, improve the quality and introduce time reductions required for customs clearance services through the application of the "One Stop Shop / Single Window" concept.

The Borrower is the Republic of Armenia represented by the Ministry of Finance. The Project Implementing Agency is the State Revenue Committee (SRC) of the Republic of Armenia, which is the tax and customs authority of the Republic of Armenia.
