### Project Description

According to the Bank's website, the project consists of a senior unsecured loan of up to EUR 5.0 million to be provided in one tranche to Raiffeisen Bank Kosovo ("RBKO") under the FIF - SME Go Green Programme ("SME Go Green").

The loan proceeds will be used for providing sub-loans to eligible SMEs in Kosovo for improving their competitiveness and trade potential via targeted investments in sustainability practices and the adoption of internationally recognised quality standards, scaling up green economy investments and in particular, greening of agribusiness supply chains and promoting more equitable access to climate and other finance to women-led SMEs. The bank will aim to deliver 100 per cent of the proceeds to Green Economy Transition (GET) eligible projects.

RAIFFEISEN BANK KOSOVO JSC - RBKO, a subsidiary of Raiffeisen Bank International ("RBI"), is the largest commercial bank in Kosovo with EUR 1.4 billion in total assets as of YE2023 (19.6% of the system's total). The bank is headquartered in Pristina and has the largest network in the country with 36 branches and 910 employees at YE2023. It operates as a fully owned subsidiary of RBI that is rated A1 (stable) by Moody's and A- (negative) by S&P.
