Project Description

According to the Bank's website, the project consists of the provision of a senior secured loan of up to USD 25 million to Northvolt Systems AB, a company specialised in providing battery solutions for energy storage systems and industrial application, for the development of an industrial-scale manufacturing plant for battery solutions in Gdansk, Poland.

The objective of this project is to finance the core capex plan for the period 2024-2025, covering investments in production equipment for battery products for Energy Storage Systems ("ESS") and industrial applications.



Early Warning System Project Analysis

Categorised B (2019 ESP). E&S due diligence has shown that the E&S risks and impacts associated with the project, and the battery system assembly facility at which it will be located, are limited.

The facility required the clearance of land, including a small, forested area. The facility is distant to any protected areas and no significant sensitivities were identified on site.



Investment Description

- European Bank for Reconstruction and Development (EBRD)

A senior secured loan of up to USD 25 million. The project benefits from InvestEU guarantee of 25% first-loss cover.
