According to the Bank's website, the project consists of the provision of a senior unsecured loan to Garanti Leasing Romania in the amount of up to EUR 10 million for on-lending to local micro, small and medium-sized enterprises ("MSMEs") in Romania under the Financial Intermediaries Framework ("FIF").

The proceeds of the loan will be used to provide lease finance to local MSMEs. At least 30% of the proceeds will be directed to finance Green Economy Transition ("GET") eligible investments.
