## Project Description

As stated by the EBRD, the project consists of the provision of a sovereign loan of up to USD 30 million to finance the purchase of autotransformer equipment for reinforcing works at four operational substations in Azerbaijan. The Republic of Azerbaijan represented by the Ministry of Finance will act as the borrower. Azerenerji OJSC will act as the implementing entity for the Project.

The Project will help to improve the flexibility of the power system in Azerbaijan required to integrate renewable energy capacities. The successful implementation of the Project would set an example for further grid strengthening projects that are important for the integration of renewable energy projects in the country.

The Project will promote the connection of planned renewable energy installations which currently are not possible due to inadequacy of the grid or lead to a decrease in the curtailment of existing renewable energy installations. The Project will also promote a policy engagement, which aims to deliver institutional reform and lead to structural changes across sectors/markets.

The Borrower is the Republic of Azerbaijan represented by the Ministry of Finance. Azerenerji OJSC, an Azerbaijani state-owned enterprise, which is responsible for generation and transmission of electricity in the country, will act as the implementing entity for the project.
