#### **Project Description**

As stated by the EBRD, the project consists of the provision of a sovereign guaranteed loan of KZT 232.6 billion (EUR 449 million equivalent) in favour of JSC NC KazAvtoZhol, the national road operator in Kazakhstan. The loan will part-finance the design and civil works, as well as related consultancy services, for the reconstruction and upgrade of a 234-km section of the Aktobe-Ulgaisyn road. The project will be co-financed by the AIIB and by the Republic of Kazakhstan.

The objectives of the project are the reconstruction and upgrades (from 2 to 4 lanes) of a 234-km long road section between the cities of Aktobe and Ulgaisyn, and the improvements in inter-regional connectivity, safety standards, increased road capacity and reduced travel time.
