Project Description

According to the Bank's website, the project consists of the provision of a five-year senior unsecured loan of up to EUR 10 million equivalent to ProCredit Bank SA (PCBM) under the SME Competitiveness and Inclusion Programme in the Eastern Partnership for on-lending to eligible micro, small and medium enterprises (MSMEs). The loan will be available for disbursement in Moldovan Lei or in EUR.

In addition to long-term financing, eligible sub-borrowers will receive technical assistance funded by the European Union and grant support in the form of investment incentives upon the completion of their investment projects.

Through the SME Competitiveness and Inclusion Programme in the Eastern Partnership credit line and advisory support under this framework, ProCredit Bank will support upgrades in micro, small and medium-sized enterprises (MSME) to European Union (EU) standards. The proposed project will enable ProCredit Bank to extend loans for investment purposes to local MSMEs, financing upgrades of technology and equipment necessary to meet EU standards in terms of product quality, health and safety measures and environmental preservation and thus will help businesses to become greener and more competitive.


Financial Intermediary
