## Project Description

According to the Bank's website, the project consists of the provision of a senior unsecured loan of up to EUR15 million, under SME Go Green Programme, to Banca Intesa Belgrade ("BIB").

Proceeds of the Loan will be used for providing sub-loans to eligible SMEs in Serbia for improving their competitiveness and trade potential via targeted investments in sustainability practices and the adoption of internationally recognised quality standards, scaling up green economy investments and in particular, greening of agribusiness supply chains and promoting more equitable access to climate and other finance to women-led SMEs. BIB will aim to deliver 70 percent of the proceeds to Green Economy Transition (GET) eligible projects.
