## Project Description

According to the EBRD, the transaction envisages provision of a senior loan of up to EUR 20m for financing the company's working capital needs and capital expenditures.

The main objective of the project is to provide the company access to working capital funding needed to mitigate 2023 Türkiye earthquake consequences, in turn leading to improved resilience of the company's balance sheet and support the company's growth.

The project will be supported by a donor funded technical assistance assignment from CIF-PPCR donor funds.
