

# **Project Description**

As stated by the EBRD, the project consists of a senior secured loan of up to EUR 6M to fund the company's expansion plans comprising of the construction of a new processing facility and related equipment purchases. The Project will be co-funded on a pari-passu basis between EBRD and the Enterprise Expansion Fund II (ENEF II), each providing up to EUR 3M. The EBRD loan includes a concessional finance tranche from the High-Impact Partnership on Climate Action (HIPCA) special fund in the amount of up to EUR 1M.

The Project will support the Company's expansion plans enabling its relocation from existing site to a modern facility for collection, processing, and sorting of metals scrap. The Project will also support enhanced sustainability measures expected to lead to improved environmental footprint via reduction of greenhouse gas (GHG) emissions, green building certification (EDGE 'standard' rating), increase in recycled materials and adoption of gender inclusion policies.

Legal consultancy for due-diligence and preparation of financing documents with costs up to EUR 68,000 will be covered 80% from ENEF II related TC funds and 20% from the client's contribution.




