## Project Description

According to the Bank's website, the project consists of a senior unsecured loan of up to EUR15 milion to Banca Intesa Beograd ("BIB"), under the WB Youth in Business Programme.

The proceeds of the Bank's investment will be used for eligible Youth MSMEs (i.e. youth-led or youth-owned MSMEs) in accordance with the respective Policy Statement.

## Investment Description

A senior unsecured loan of up to €15 milion.

## Financial Intermediary

Financial Intermediary: A commercial bank or financial institution that receives funds from a development bank. A financial intermediary then lends these funds to their clients (private actors) in the form of loans, bonds, guarantees and equity shares. Financial intermediaries include insurance, pension and equity funds. The direct financial relationship is between the development bank and the financial intermediary.

### Private Actors Description

Banca Intesa Belgrade ("BIB") is the largest bank in Serbia and is among the leading banks in both corporate and retail banking. As of August 2024, BIB had a market share of 15.4% by total assets, 17.2% by net loans and 16.9% by deposits. BIB has been one of the most profitable banks in Serbia for many years, thanks to economies of scale, good diversification and efficient operations. It has approximately 3,000 employees and a branch network of 141 offices across Serbia.
