## Project Description

As stated by the EBRD, RG Brands Kazakhstan LLP is the leading regional beverage producer, incorporated in Kazakhstan. The transaction envisages the provision of a long-term secured loan of up to EUR 21 million to RG Brands Kazakhstan LLP.

The loan proceeds will be utilised to (i) finance capital expenditure programme, including green capital expenditure and (ii) finance working capital needs.

The Project will have a Technical Cooperation (TC) component provided by the Japan-EBRD Cooperation Fund (JECF). The TC funds will cover 65 per cent of the legal due diligence costs. Remaining 35 per cent will be contributed by the client.
