According to EIB website, the project is consist of a framework loan to support thermal building refurbishment in the municipality of Chisinau. The project includes two components; the first component will focus on the renovation of a list of pre-identified public buildings. The second component will be structured as a framework loan and allocations will target both the public and residential sectors.

It intends to increase the energy efficiency of public and residential buildings, which will have a significant impact on CO2 emission reduction and thus contribute to climate change mitigation. Besides this, energy efficiency investments will generate local and regional economic activity, particularly in the construction industry, and therefore support the development of the private sector and small and medium-sized enterprises (SMEs).

A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
