Project Description

This project expands and modernizes logistics infrastructure for Nibulon. Components include: a) the construction of river and in-land terminals with grain elevators; b) the upgrading of a transhipment terminal; c) the modernization of Nibulon's shipyard; d) the construction of tugboats and barges for transportation of cereals by inland waterways.

The project is expected to remove existing bottlenecks in the transportation and storage of cereals, reduce the in-land transportation costs, and increase the annual volume of exported agricultural commodities.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
