According to EIB website, the project consists of an investment programme by the UniversitAS Catholique de Louvain (UCL), a leading Belgian university based in Louvain-la-Neuve. The EUR 200m investments are aimed at the construction and retrofitting of educational and research infrastructure to be carried out during the 2017-2021 period. It intends to upgrade the educational and research infrastructure of UCL to strengthen its domestic and international academic standing.

The client will ensure compliance with national and European environmental and natural regulations and facilitate public access to environmental information in line with the Bank's transparency policy.

### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
