#### **Project Description**

According to the Bank's website, the project will finance the construction and equipping of two new regional hospitals in the Republic of Moldova: the Balti Regional Hospital (BRH) in the north and the Cahul Regional Hospital (CRH) in the south.

The aim is to decentralise tertiary healthcare services and improve their accessibility in both the northern and southern Moldova, thereby enhancing the overall provision of healthcare in the country. The project will support the effective implementation of Moldova's National Health Strategy 2022–2030 by strengthening social assistance mechanisms and promoting an inclusive society. This will be achieved through improved access to hospital care and by enhancing the outreach and quality of healthcare services.

#### **Early Warning System Project Analysis**

According to the Environmental and Social Data Sheet:

In the Republic of Moldova, the law regulating Environmental Impact Assessment (EIA) is Law No. 86, adopted on 29 May 2014. This law establishes the legal framework for assessing the environmental impact of certain public and private planned activities.

Based on the information provided to the Bank, the construction of the new hospital will not require any land acquisition and result in involuntary resettlement. Should the need for land acquisition and any involuntary resettlement in relation to the construction of the Cahul Regional Hospital arise, the relevant Bank standards will apply.
