As stated by the EIB, the project will finance the construction of a 56.7 km section of the M85 expressway between Csorna and Sopron.

The new M85 expressway is an element of the Vienna-Wiener-Neustadt-Sopron-Győr-Budapest strategic corridor included in the Hungarian National Transport Infrastructure Development Strategy. The project is located in a less developed region both under the 2014-2020 and 2021-2027 EU Cohesion policies.
