Project Description

According to EIB website, the project will be financing research and development activities undertaken in public universities and public scientific institutes. The project supports investments in intangible scientific activities. It aims to further strengthen the public science and innovation system and facilitate Poland's contribution to the common European Research Area. The universities are located in all regions of the country, which in large part is classified as less-developed.

The project concerns activities in research and development that are expected to be carried out in existing facilities already used for similar activities, and are therefore not covered by the Environmental Impact Assessment (EIA) Directive 2011/92/EU, as amended by Directive 2014/52/EU.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. A complaint can be lodged via a written communication addressed to the Secretary General of the EIB, via email to the dedicated email address complaints@eib.org, by completing the online complaint form available at the following address: <http://www.eib.org/complaints/form>, via fax or delivered directly to the EIB Complaints Mechanism Division, any EIB local representation office or any EIB staff. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
