According to EIB website, the project relates to the design and roll-out of a publicly owned fibre broadband network public initiative network (PIN) in the Maine-et-Loire department, France. It intends to deploy a fibre-to-the-home (FTTH) network that will connect around 220,000 sites including homes, businesses, public sites and mobile radio stations. The access networks included in the project will be deployed in areas where private operators do not provide very high speed broadband services due to lack of commercial interest. EIB finance is not disclosed.

ACCOUNTABILITY MECHANISM OF EIB

When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
