Project Description

According to the Bank's website, the loan will finance the development of new academic, research and related buildings to form part of a new modern campus for the University of Milan, to be located in the heart of the Milan Innovation District (MIND), on the former 2015 Milan EXPO site.

The new MIND campus will cover an area of approximately 220,000m2, which will include teaching, learning and research space, including laboratories and sports infrastructure.

The project will be delivered through a Public Private Partnership (PPP) scheme.

The aim is to provide modern teaching and research space for the University of Milan's science and technology departments. The new MIND campus is expected to increase the university's competitiveness and attractiveness to talent through access to state-of the art laboratories and instruments for both teaching and research.



ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. A complaint can be lodged via a written communication addressed to the Secretary General of the EIB, via email to the dedicated email address: complaints@eib.org, by completing the online complaint form available at the following address: http://www.eib.org/complaints/form via fax or delivered directly to the EIB Complaints Mechanism Division, any EIB local representation office or any EIB staff. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
