- 2. Continue the development of specific products in line with customers' need and to maintain its technical leadership and expand to new markets.

S.P.C.M. SA, through its subsidiaries, designs, manufactures, and sells chemical products. The company provides polyacrylamide (PAM), a water-soluble specialty chemical used in water treatment, mineral extraction, pulp and paper manufacturing, and other industries, as well as in oil and gas applications, including enhanced oil recovery. It also offers related specialty chemicals, such as coagulants, which are primarily used in water treatment and monomers; dispersants used in the paper, household products, and mining industries; mining reagents, which are used in the minerals processing industry; and equipment that facilitates the utilization of PAM.

#### **ACCOUNTABILITY MECHANISM OF EIB**

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
