According to EIB website, the project, to be carried out in Belgium and France over the period 2018-2021, concerns investments in a stainless steel advanced manufacturing cold rolling mill and finishing equipment. It will also finance the modernisation programmes of two stainless steel plants located in cohesion regions.

Further, it aims to strengthen the promoter's market position in a specific stainless steel grade segment by replacing obsolete downstream equipment with a new high-tech, highly automated advanced manufacturing line which will also slightly increase downstream manufacturing capacity of a high value added product.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
