Project Description

According to bank provided information, the project concerns the design, construction and operation of a reverse osmosis sea-water desalination facility, with production capabilities of 200 million m³ per annum, under a public-private partnership (PPP) scheme, located in Sorek, Israel.

The project is intended to ensure access to water and have a climate change adaptation and mitigation impact addressing persistent droughts and increased demand for water.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
