### **Project Description**

According to the bank website, the project concerns the construction in North Macedonia of a gas interconnection with Greece, identified as a Project of Mutual Interest by the Energy Community. The Greece side is covered by the project "GAS INTERCONNECTOR GREECE-NORTH MACEDONIA GRPART 2019-0190". The main objective of the project is to enable security of gas supply for North Macedonia, through a diversification of gas sources and access routes. The project will also pave the way for further integration of the national gas market and infrastructure within both the Western Balkans region and the EU.

#### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
