Project Description

As stated by the EIB, the project will finance the investment into rolling stock and related infrastructure for the local transport company in the capital and second biggest city of the German state of North Rhine-Westphalia. In particularly, it concerns purchase of about 100 new high floor Light Rail Vehicles (Stadtbahn) for the existing light rail network, which also reaches the neighbouring cities of Duisburg, Krefeld and Neuss.

The project will contribute to improve the quality of public transport service in terms of comfort and reliability and will uphold the attractiveness of public transport in the metropolitan area, thus contribute to a reduction of reliance on private cars and their negative impact on the environment and congestion.

ACCOUNTABILITY MECHANISM OF EIB

Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
