Project Description

This project will finance the construction of the Greek section of the Greece-North Macedonia gas interconnector, which is 55km-long that will optimise the use of the national gas transmission system. The North Macedonian side is covered by the project "GAS INTERCONNECTOR GREECE-NORTH MACEDONIA NMPART" which will provide security of gas supply and competition between supply sources, by offering a diversification of routes and sources.

The Greece-North Macedonia pipeline falls under Annex II of the Environmental Impact Assessment (EIA) Directive 2011/92/EU (amended 2014/52/EU). The EIA included consideration of potential cross-border impacts and the involvement of the competent authority in response to notification of the project under the Espoo Convention.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
