### Project Description

As stated by the EIB, the project involves the design, construction and equipping of a new state-of-the-art teaching and research facilities of the Jagiellonian University Medical College (CMUJ) in the Prokocim District of Krakow.

The project involves the significant extension of the medical campus and related teaching and research activities, the construction and equipping medical simulation facilities, laboratories, lecture halls and seminar rooms as well as and administrative infrastructure.

The aim is to intensify the development of the medical campus by combining the university's academic, research, laboratory and administrative departments into a single site. This will support and increase the university's activity in the area of medical education, training and research, by modernising its academic and research facilities, thus further enabling interdisciplinary research with the existing university's hospitals based in the medical campus.

Being located in Krakow, a cohesion region, the project also contributes to EU cohesion objectives.

## **ACCOUNTABILITY MECHANISM OF EIB**

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
