#### **Project Description**

According to the bank website, the project consists of the implementation of several components of a new investment plan at the Ports of Genoa and Savona, including several different components like the new Genoa breakwater, new rail accesses and terminals, ship-to-shore electric connections (cold ironing), rehabilitation of existing quays and implementation of security measures and related IT infrastructure. Other components in the port area (and always related to the operational needs of the port) may be included in the framework loan during appraisal or later, during allocation of funds.

#### ACCOUNTABILITY MECHANISM OF EIB

When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union. 
