Project Description

France Investissement Tourisme 2 is an initiative of Bpifrance Investissement taken in response to the COVID-19 crisis and focusing on tourism investments. FIT2 aims at reaching a target size of EUR 240m. It aims to provide financial support to about 100 tourism operators (SMEs and small mid-caps) lacking the own resources and financial stability to access the necessary funding in order to upgrade or expand their business, even more so after the outbreak of the COVID-19 crisis.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
