#### **Project Description**

According to the EIB, the project consists of investments in the implementation of one pumped-storage hydropower project (150 MW) and in the implementation of a run-of-river hydropower plant (28 MW) bypassing three old plants to be deconstructed in Austria in the period from 2024 to 2028.

Notably Ebensee PSH received the full environmental approval in 2017 under UVP-G 2000.

For Traunfall HPP an extensive environmental impact assessment (EIA) was performed by the promoter and submitted to the competent authority (State Government of Upper Austria) in July 2023; additional documents were submitted in March 2024. It is expected that the competent authority will submit their decision in the last quarter of 2024, after completion of review and public consultations.
