## Project Description

According to the bank website, the project consists of creating a building complex including the rehabilitation of 13,000 m<sup>2</sup>, and the construction of new surfaces in extension up to 7,000 m<sup>2</sup>. It consists of the rehabilitation, extension and development of an existing building to become the metropolitan headquarters and bring together the various administrative teams in a single place.

The Metropolitan hotel project in Grenoble is part of an urban renovation operation, by reconditioning an existing building, improving its environmental footprint and improving the landscaped area that surrounds it.

### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
