Project Description

DESCRIPTION

Retrofit of around 244 pieces of rolling stock (including 13 prototypes) with the European Train Control System (ETCS) on board units.

ENVIRONMENT

The investments proposed under the project do not fall under either Annex I or Annex II of the Environmental Impact Assessment Directive 2011/92/EU as amended by Directive 2014/52/EU as manufacturing and use of rail rolling stock is not included in either list. The need of an EIA and/or assessment according to the Habitats Directive for associated facilities (e.g. maintenance workshops or depots) will be analysed during the appraisal. All else equal, the project is expected to have a positive environmental impact by helping the railways to maintain modal share in key sections of the passenger market that are most appropriately met by rail.

OBJECTIVE

By means of contributing to achieving interoperability of the EU railway system, the project is expected to improve competitiveness of rail vis à vis other modes, thereby, enhancing sustainable transport and presenting environmental and safety benefits due to preventing modal shift from rail to road.

PROCUREMENT

The Bank will require the Promoter to ensure that contracts for the implementation of the project have been tendered in accordance with the relevant applicable EU procurement legislation, Directive 2014/25/EU as well as Directive 92/13/EEC as interpreted by the Court of Justice of the EU, with publication of tender notices in the Official Journal of the EU (OJ), as and where required.

ACCOUNTABILITY MECHANISM OF EIB
