Project Description

According to the bank website, the project consists of financing of utilities in Italy under a Programme Loan. Sectors include waterworks (water and wastewater), electricity distribution, district heating, energy efficiency measures (including public lighting), renewable energy generation and waste collection/treatment facilities.

The proposed Programme Loan (PL) aims at addressing the investment needs of small and medium-sized utilities operating in the water, energy and solid waste sector, throughout Italy. In particular, the following investments are expected to be financed under the PL: (i) electricity and water distribution networks; (ii) wastewater collection and wastewater treatment schemes; (iii) waste collection, recycling, treatment and disposal facilities; (iv) district heating facilities and co-generation plants; and, (v) municipal public lighting for energy saving purposes.

A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
