## **Project Description**

According to the Bank's website, consists of co-financing investment schemes supported by the European Regional Development Fund, the European Social Fund and the Just Transition Fund in Andalusia within the Spanish Partnership Agreement 2021-2027.

The Project is expected to co-finance investments made by the regional government of Andalucía in the period of 2021-2027 under the following two regional Operational Programmes (OPs): the OP for investment in growth and employment supported by the European Regional Development Fund (ERDF) and the OP for Social Inclusion and Employment supported by the European Social Fund (ESF).

Furthermore, the Project will also co-finance investments made under the EU's Just Transition Fund in the region, given that Andalucía also hosts some territories considered as most affected by the transition to a low-carbon economy.

### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
