Project Description

According to the Bank's website, the project consists of an investment loan to Sofia Municipality to co-finance alongside the Recovery and Resilience Facility (RRF) the construction of the third stage of Sofia Metro Line 3. The project includes a twin-track metro line of approximately 8.6 km in length, 9 metro stations and the acquisition of new rolling stock for the metro network. The construction is divided into two lots: 3.0 km of twin tracks and 3 metro stations for Lot 1; and 5.6 km of twin tracks and 6 metro stations for Lot 2.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
