Some of the projects will be located in cohesion regions.

The project concerns a Programme Loan targeting energy efficiency projects (mainly in buildings and small/medium-sized enterprises) as well as small/medium renewable energy projects (mainly photovoltaic, wind and biogas) in Italy trough acceptable promoters (banks, utilities, energy service companies, etc.) who will play the role of aggregators of small energy projects and on lend to the final beneficiaries.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
