Project Description

DESCRIPTION

Financing the first phase of the long-term investment programme of Sint Franciscus Gasthuis and Vlietland, a general hospital operator in the greater Rotterdam area.

ENVIRONMENT

Hospitals are not explicitly mentioned in the EIA Directive 2014/52/EU amending the Directive 2011/92/EU, though the project is covered by Annex II of the Directive about urban development. The Bank's services will verify during appraisal the screening decision of the competent authority.

It is expected that the project will bear more comprehensive benefits to the community as healthcare is an element of social cohesion and economic development.

OBJECTIVE

The project covers the first phase of the Promoter's long-term strategy for reorganising service delivery across its two hospital facilities. It includes the construction of a new building (about 20 500 m²) on the site of the Franciscus Gasthuis which will enable the consolidation of a number of functions in a modern, state-of-the-art environment. Investments will hence support efficient and modern healthcare provision in the greater Rotterdam region.

PROCUREMENT

The Bank will require the Promoter to ensure that contracts for the implementation of the project have been and will be tendered in accordance with the relevant applicable EU procurement legislation (Directives 2014/24/EC and/or 2014/23/EC as well as Directives 89/665/EEC and 92/13/EEC) as interpreted by the Court of Justice of the EU, with the publication of tender notices in the Official Journal of the EU, as and where required.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
