
Project Description

According to the bank website, the project consists of a loan in support of a Just Transition in Western Macedonia. The project comprises the schemes under the investment programme of the Western Macedonia Region (Dytiki Makedonia) aiming to support the implementation of the Territorial Just Transition Plan of the region.

The proposed operation aims to address some of the social, economic, environmental and climate transition challenges of Western Macedonia, a region traditionally dependent on coal and lignite mining, heavy industry and fossil-fuel power generation. This is a multisector operation expected to address some of the development needs of the region in the sectors of energy efficiency, transport, tourism, culture and health.

PROCUREMENT

The Bank will require the Promoter to ensure that contracts for the implementation of the project will be tendered in accordance with the relevant applicable EU procurement legislation: Directive 2014/24/EU, Directive 2014/23/EU, where applicable as well as Directive 92/13/EEC and Directive 89/665/EEC as interpreted by the Court of Justice of the EU, with publication of tender notices in the Official Journal of the EU, as and where required.



ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
