#### **Project Description**

According to the Bank's website, the project supports the defined investment programme in 2021-2026 of the Wellbeing Joint Authority for Helsinki and Uusimaa (HUS) including construction and renovation of hospital and health care buildings in the Uusimaa region in southern Finland.

The project concerns the replacement of an existing hospital building on the Meilahti site of the University Hospital in Helsinki with a new building as well as the extension and rehabilitation of several other hospital facilities on the same site as well as in Espoo (Jorvi Hospital) and Vantaa (Peijas Hospital).

HUS, or HUS, is a public-law entity established on 1 January 2023 by a basic agreement between the City of Helsinki and the four wellbeing services counties of the rest of Uusimaa in the health and social services reform of the Marin Government. The City of Helsinki and the wellbeing services counties of the rest of Uusimaa have a statutory obligation to belong to the HUS consortium.

In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
