Project Description

According to the bank website, the project concerns the construction, renovation, refurbishment, restoration and/or extension of academic, research and associated higher education infrastructure, including sports facilities and student residences. The programme loan will support the co-financing of capital investments in Italian public universities, who are also beneficiaries of capital grants from the Ministry of Universities and Research.

The universities expected to receive complementary financing from the EIB are likely to include climate action and environmental sustainability objectives in their investment plans as well as universities located in supporting less developed and transition regions will be a priority.

A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
