Project Description

According to the Bank's website, the project consists of investments in water and wastewater infrastructure over the 2022-2027 period.

The project concerns the 2022-2027 water and wastewater investment programme of the Promoter aimed at ensuring compliance with tighter environmental requirements set by national and EU legislation, notably the Drinking Water Directive 98/83/EC, the EU Urban Wastewater Treatment Directive 91/271/EC as amended by 98/15/EC ("UWWTD") and the Water Framework Directive (2000/60/EC). The project will also contribute to meeting the customer service standards set by the in-house agreement and the Key Performance Indicators set by the regulator ARERA.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
