## Project Description

As stated by the EIB, the project concerns Piaggio's investments in research, development and innovation related to technologies applicable to electric two-wheelers and electric light commercial four-wheeler. The related activities will be carried out at the promoter's RDI premises in Italy, in the period 2022-2025.

The primary objective is to develop zero-emission technologies and products for two-wheeler and light commercial vehicle applications.

Investments also aim to set-up an "E-mobility" laboratory and testing centre, as well as to develop and deploy cybersecurity technologies. The project addresses the main societal trends driving the sector's development, notably the increasing urbanisation and the need to develop sustainable mobility solutions, particularly in urban and suburban areas.

## ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
