### **Project Description**

According to the Bank's website, the project entails the financing of a fleet of Uncrewed Surface Vessels (USVs) for collecting ocean data, mainly to the benefit of the offshore wind energy sector and marine science.

The main goal of the project is to accelerate the development and deployment of innovative ocean monitoring solutions with Uncrewed Surface Vessels. The project will support the company to develop further its ability of providing ocean surveys with integrated data sets (including weather data, vessel traffic data and other relevant variables) for the sustainable development of ocean assets, in particular offshore wind farms.

#### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
